that complaint being brought forward to this board, I advised you to seek the services of an independent firm to investigate that complaint, The Board authorize the hiring of Webster Szanyi LLP, a law firm out of Buffalo. They have a number of lawyers who specialize in municipal labor employment law and are very familiar with these types of matters and conduct such investigations on a regular basis. They were engaged to act as independent third-party consultant in the review of the complaint. They investigated the matter over the course of a month or month and 1/2 and that investigation involved the interview of certain witnesses, including the complainant.

As a result of that investigation, I was provided with a written report from Webster Szanyi LLP was provided to me as the Attorney for the Town. The Attorney-Client privilege applies to that report, so that it is not a public record. The substance and conclusion of that report was that there was no finding to substantiate the allegation the allegations of workplace violence The allegations that were made in the complaint did not rise to the level of meeting the requirements of our workplace violence prevention policy.

I did after reviewing and talking with the investigators, issue a letter dated October 20th which I sent to each of the Town Board Members. It basically summarizes that the investigation has been completed and that there was no finding of any impropriety as it relates to workplace violence. So, from my standpoint that investigation is concluded and the document remains with me. Typically, there would be nothing else done with it, that matter is closed and resolved at this point.

#### **LOCAL LAW NO. 5 OF THE YEAR 2022**

#### OF THE TOWN OF AVON

A local law to amend the Zoning Ordinance of the Town of Avon, Livingston County, New York to modify Chapter 130 Article VI and Article XV.

Be it enacted by the Town Board of the Town of Avon as follows:

#### SECTION 1. TITLE AND SCOPE

This local law shall be known as "A LOCAL LAW TO AMEND CHAPTER 130 ARTICLE VI AND ARTICLE XV OF THE ZONING ORDINANCE OF THE TOWN OF AVON, SPECIFICALLY TO ADD A NEW SECTION TO ARTICLE VI SPECIAL USE PERMITS, BEING §130-35 B. (2) (a) WHICH ADDRESSES TRANSFER OF PROPERTY THAT HAS AN APPROVED SPECIAL USE PERMIT AND TO ADD A NEW SECTION TO ARTICLE XV SOLAR ENERGY SYSTEMS, BEING §130-81 O. WHICH ADDRESSES UNDER WHAT CONDITIONS A SOLAR ENERGY SYSTEM CAN BE MADE OPERATIONAL."

#### SECTION 2. PURPOSE.

A. Authority. This Local Law is adopted pursuant to the Town Law of the State of New York, Chapter 62 of the Consolidated Laws, Article 16, and Articles 2 and 3 of the Municipal Home Rule Law, to protect and promote public health, safety, convenience, order, aesthetics, prosperity and general welfare of the Town of Avon in a fashion that is not inconsistent with the Comprehensive Plan of the Town of Avon. This Local Law regulates the use of buildings and structures and the development and use of land within the Town of Avon.

- B. To these ends, this local law and the Articles of the Town of Avon Zoning Ordinance that it amends is designed to:
  - 1. Enhance and regulate the orderly growth, development and redevelopment of the Town in accordance with a well-considered plan so that the Town may realize its potential as a place to live and work; and
  - 2. Protect and manage the character of the Town.

# SECTION 3. <u>CHANGES TO ARTICLE VI, §130-35 - USES REQUIRING SPECIAL USE</u> PERMITS.

The current Article VI, §130-35 of the Zoning Ordinance of the Town of Avon is hereby modified and amended to add a new section that shall be known as §130-35 B. (2) (a) and shall read as follows:

"(a) Transfer of Property with Special Use Permit. A special use permit authorizes only the activity expressly described in the application and approved special use permit materials. A special use permit shall expire upon change in property ownership or property transfer, unless the Building and Zoning Office is notified by the owner, in writing, prior to property transfer and the Zoning Board of Appeals reviews the use or activity and special permit documents and is satisfied that the use has and will continue to be conducted in a manner that is consistent with the special use permit and any conditions which may have been stipulated at the time of its issuance and approves, in writing, the transfer of the special use permit. If the Zoning Board of Appeals does not issue a written response within 30 days of notification by the property owner, such lack of response shall constitute approval of the continuation of the special use permit under the same conditions as previously approved. A new special use permit shall be required for any expansion, alteration or variation of a use already authorized by a special use permit. A request for a new special use permit shall be subject to the application and review procedures described in this Article and elsewhere in the Zoning Ordinance of the Town of Avon, as applicable."

# SECTION 4. <u>CHANGES TO ARTICLE XV</u>, §130-81 <u>- SOLAR ENERGY SYSTEMS:</u> <u>GENERAL REGULATIONS</u>

A. The current Article XV, §130-81 of the Zoning Ordinance of the Town of Avon is hereby amended to include a section is designated as "§130-81 O." and shall read as follows:

"O. No Commercial Building-Mounted Solar Energy System, Commercial Roof-Mounted Solar Energy System, Type 1 Solar Energy System requiring Site plan approval or Type 2 Solar Energy System shall be made operational until such time that all conditions of approval relating to the Site Plan and Special Use Permit have been satisfied, the System fully complies with the solar regulations in Article XV of the Town of Avon Zoning Ordinance

and a Certificate of Compliance or Certificate of Occupancy has been issued by the Code Enforcement Officer. Should any such Solar Energy System be made operational prior to the above conditions being fully met and satisfied, it will be deemed a violation and may result in revocation of the Site Plan approval and/or Special Use Permit approval, along with any other remedy available pursuant to the Town of Avon Zoning Ordinance or New York state law."

### SECTION 5. <u>EFFECTIVE DATE</u>.

This local law shall be effective thirty (30) days after its filing with the Office of the Secretary of State.
