## **DISCUSION SOLAR**

Supervisor LeFeber welcomed Bob Stryker from Livingston County Soil and Water Conservation District.

Bob addressed the Board with the following:

# **DISCUSION SOLAR-continued**

### **Weather Stations**

The Conservation District was established 76 years ago to address water and resource concerns with direct input from local municipalities. We promote practices that assist land owners.

At their March meeting the County agreed to provide each town with a weather station (at no cost) to get real time weather data that can be utilized for many reasons; such as emergency weather or disaster information.

It will be available to all Avon residents through a phone app from Davisnet.com. It would be located at the Town Hall or Highway department. The town would be required to maintain the unit and internet access. The Town Board will decide where to place the unit.

The base unit is \$650.00 and districts obtained monies through New York State for this project. The ones that were purchased are battery run.

A sheet was provided regarding prior projects such as one that was provided to the Village of Avon.

### Soils

Several maps were distributed along with soil classifications which are Prime Farmland, not prime farmland, unique farmland and Farmland of state wide importance.

There were questions on how profitability is determined.

What's the role of lime in our soils? If the soil is acidic you would add lime.

Cathy Gardner – Town of Lima. How does Avon and Lima fit in the context of the State? We are truly in the bread basket of soils of the State.

Clay soil is very productive and falls under the classification of state wide importance. It is good for hay production.

Supervisor LeFeber reviewed the accomplishments of the last meeting.

Attorney Campbell stated that the 2 policy standpoints are the permissibility of the use of prime soils or soils of statewide significance and the issue of taxation. Will the town opt out or leave as is allowing properties to continue to be tax exempt. There is the option of

PILOTS or do we want to develop a formula across the board or have individual application considerations.

### **DISCUSION SOLAR-continued**

Decommissioning is something that the Board wants to do and we need to wordsmith the document.

Supervisor LeFeber asked if other communities are allowing a certain percentage of prime soils to be dedicated for solar use. Attorney Campbell answered that other communities are allowing this.

Lima was considering moving forward but wanted to wait for the latest model. They decided not to permit solar on prime soil farmland. Seven farmers voted to not allow and the County Planning Board agreed. The direction is to not permit. The State has been working with the Governor's Office to provide greater funding to have solar on lands other than prime land.

Other communities are not allowing solar in places that have been active within the last five to ten years.

Bruce Howlett shared his recommendations regarding how prime lands are identified and how they are profitable.

There was discussion about restoring land if and when solar panels are removed. The model code from the State is being included in our draft local law.

Councilman Drozdziel questioned what is coming to the town and what is the benefit? What are you bringing to the residents? There needs to be balance.

Other towns are being provided with infrastructure benefits and negotiations are happening. One addition could require a PILOT and determine what would be included. This could be addressed in your fee schedule and there is changing values.

Gary Wheat stated that he has residential solar and has been approached by a solar company regarding commercial solar so he has a vested interest. He regards solar as a peaceful, quiet, friendly, maintenance free product. The Comprehensive Plan for Avon includes; encouraging global energy systems for commercial, residential and industrial that is appropriate including wind, solar and geo-thermal.

It was suggested that the town does not opt out of the PILOT program.

Attorney Campbell stated that towns and counties are adopting by resolution a plan process for payments in lieu of taxes for ten years. Assessor Snyder will come up with examples from other municipalities.

Percentage of prime soil that can be used for solar can be determined by the town.

The board seems to be in agreement that they are in favor of commercial solar coming to Avon.
