A regular meeting of the Town of Avon was held on Thursday, July 11, 2019 at 6:00 P.M. at the Avon Opera Block/Town Hall, 23 Genesee Street, Avon, New York 14414, with the following members present:

Supervisor LeFeber called the meeting to order at 6:00 P.M. and led those in attendance in the Pledge of Allegiance.

## **DISCUSSION – VISITORS COMMENTS**

Supervisor LeFeber asked for visitor comments stating that both public hearings are open from the last meeting. The comments follow:

## OPEN PUBLIC HEARING RIGHT TO FARM LOCAL LAW T-2A-2019

Visitor Judy Falzoi addressed the Board regarding Local Law T-2A-2019 Right to Farm Law of the Town of Avon. Judy provided five objections that can be easily corrected tonight. After reading and comparing other nearby towns' Right to Farm Laws I found a few differences with Avon's law being considered tonight.

The definition of activities. An example of an activity could be to run cows around the circle. She suggested that any activities defined according to New York State Farm Law.

Request to remove: "Including residential buildings"

Authority to engage in agricultural practices. It should be changed from farm operations to farm operator or something because it should be a person.

Disclosure gave some notes stating it could be a lot better.

Resolution of disputes – Town of Rush does not have a dispute committee it falls on the Code Enforcement Officer. It should read supported by mutual agreement not opinion and the resolution should not conflict with any state or federal law. She suggested a ZBA or Planning Board member be on the committee and should not include a special interest group.

## **DISCUSSION – VISITORS COMMENTS-continued**

Delete two sentences take out legal counsel and/or remove costs. Lima or Livonia laws do not have those conditions in it. If you are keeping it in it then you should expand to other areas in the code.

Janet agree with Judy's points. Advisory committee dispute should be removed for several reasons. One is it could cause more conflict than it will solve, it may pit farmers versus other residents, and may provide a loophole, that allows the farming community to continue to farm while these items are in dispute.

Visitor Kellen asked if a new proposal had been received by LA&L Railroad regarding rezoning on Route 15?

Attorney Campbell reported that he has spoken with Engineer Andrew Costa from Clark Patterson and he feels that a lot of the anxieties would be relieved by amending the application for rezoning. One of the sticking points is access under Route #15 and that is problematic. It was suggested to go back to his client to amend the proposal. Heather Ferraro from the Livingston County Planning Board agreed that this would alleviate many problems. Mr. Costa reported that his client was not receptive to reduce the Southern part but did ask that the access to Route #15 be removed as the client did not want to include from the beginning. It was described that the crossing over the railroad would take place on his property. Mr. Costa was asked to go back to his client and continue discussions with his Client. These concerns need to be addressed by the County Planning Board.

Attorney Campbell suggested to leave the public hearing open and the Board appeared to agree.

## **DISCUSSION – PUBLIC HEARING LOCAL LAW T-2B-2019 RIGHT TO FARM**

Attorney Campbell stated that the words "any activities" are defined within the document as they are weaved throughout the document. The draft local law was written with recommendations of the Right to Farm Committee.

Residential buildings are in parentheses to give the reader the heads-up that NYS Ag & Markets protects farms as well.

Attorney Campbell stated The Dispute Committee is to be used to help only if both parties agree as it's not mandated. It is not appropriate to have taxpayers pay for this service. It is like the way small claims work. Councilman Drozdziel stated that it's another onus on the town. If it's not used, then why have it.

Attorney Campbell suggested to leave the public hearing open.

Discussion continued regarding the way the Dispute Committee would work.

Councilman Harrington made a motion to close the hearing and no second was made.

Deputy Supervisor Mairs suggested taking out the Dispute Committee and then he would be happy with it.
