Supervisor David LeFeber called the meeting to order at 6:00 P.M. and led those in attendance in the Pledge of Allegiance.

<u>VISITOR COMMENTS:</u> Supervisor David LeFeber asked if there were any visitor comments and there were none.

DISCUSSION: Josh & Peter Bruckel were present and discussed activity occurring on their property at exit 9. They accepted concrete debris from the construction activities on route 390. A pile of concrete debris was located on property adjacent to the Bruckel property. They started constructing a road on their property which is in a PDD without notifying the Town Code Department. They came into the Board to discuss the violation given to them by the Code officer. To address the violation The Bruckel's need to: 1-store the material in approved conditions; 2-move forward with a sub-division application to the Town; 3-need to have site plan amendment approval.

The Bruckel's have agreed to move the concrete onto their own property. The material will be out of sight and some holes will be dug to store the concrete. At the time the concrete is moved, it will be crushed. The Board discussed the hours of operation for moving and crushing the concrete. The Bruckel's talked about using the debris to continue road construction and possibly use in certain lots that will be subdivided. It was asked if the road will be dedicated to the Town to be maintained. They answered no. Any road dedicated to the Town must meet our design criteria. Further discussion occurred about details of the sub-division. The board took the following action:

employees as well as maintaining the conditions of our roads and builds reserves for future highway equipment purchases.
